

ACHIEVEMENTS OF PRESENT KARNATAKA AYURVEDIC AND UNANI PRACTITIONERS BOARD

1. Board was established in March 1965 under Karnataka Ayurvedic and Unani Practitioner Act 1961 to register doctors of AYUS & Integrated System.
2. Board has undertaken modernization, digitization & online registration of all registers.
3. First time in India the board decided to implement transparency in registration by implementing biometric on-line registration to doctors with required qualification in the system of Ayurveda, Naturopathy & Yoga, Sidda, Unani and Integrated (ISM & Modern System) of Medicine.

And with intension of stream-lining all the old registration into the same process the government issued a circular to refresh the registration of all the registered medical practitoners in this Board.

4. The Board formed a task force in district level including a Board Member with District Ayush Officer as implementing officer to take action against fake doctors as per the Board Act.

On November 22, 2013, this task force raided the fake doctors clinic all over the state and filed FIR against 15 fake doctors on a single day operation.

5. In Tumkur District on 24/02/2012, three cases filed against fake doctors was made B-report and in this case Registrar and President gave witness and the B-report has been cancelled.
6. Board has digitized all records of registered practitioners and is about to take action on all unqualified quack doctors in the state.
7. The Board organized a forum of all AYUS Boards of the country to bring about universal understanding among boards which is historic.

The main objective of this meet was to bring all Presidents and Registrars of all AYUS boards and councils under common platform and work towards attaining a common goal of uplifting the Indian Systems of Medicine.

8. Ayush Utsav-2014 was organised on November 22nd and 23rd, 2014 at Nehru Maidan, Mangalore and was inaugurated by the Hon'ble minister for Health and Family Welfare, Shri U T Khader. For the first time AYUSH Doctors from all corners of Karnataka were brought together under one platform.

9. "Global Wellness Meet-2016" was organised for Golden Jubilee Celebrations of KAUP board rendering service towards achieving excellence in the fields of Ayurveda, Unani, yoga, Naturopathy and Siddha, since 1965 [1965-2015]. Celebrating the 50 years of Service towards the field of Ayurveda.

To Uplift Ayurveda, to bring global awareness about Ayurveda and Yoga, to spread the message of AYUS & wellness throughout the state through a Dhanvantari Jyothi "Rath Yatra" completed about 7,000 Kms throughout the State. Celebrated seminars and conferences with meetings in all the district and some Taluk headquarters attended by all the registered practitioners of the Board, most of the Practitioners of Indian System of Medicine and Yoga and Naturopathy participated from around the world and more than 3 lakhs publics witnessed the event for 3 days (26, 27 & 28 Feb' 16).

In this event a tallest statue of Lord Dhanwantri of 124 Feet Height was recorded in Asian Book of record and another 4 records were recorded in Indian Book of Records.

- 1008 Ayurvedic recipes with medicinal values was prepared and displayed which was witnessed by all the delegates and general public.
- Maximum number of participants performed Yoga Session together.
- 65 participants pledged to donate their bodies for social cause.
- More than 250 Ayurveda related manufacturers participated in the EXPO which was visited by nearly 3 lakhs people.
- Renowned Physicians like Dr. Ashok Pai, Dr. Gopakumar A.Nair, Dr. Talavane Krishna, Dr. Shashidhar Buggi, Dr. S.R.Narahari, Dr. L.Mahadevan etc gave speech on the importance of bringing Ayurveda to the mainstream

10. Board has purchased a property of about 3400 sq.ft area at 1st floor of Brigade Plaza, Ananda Rao Circle, Bangalore – 09. On 13th of April 2016 with its own fund with co-operation of Government and shifted its administrative office to the own building on 06/06/2016 and inaugurated on 17th June 2016 is a history of the 50th Year of Golden Jubilee Celebrations.

**"FUNCTIONS OF KARNATAKA AYURVEDIC AND UNANI
PRACTITIONERS BOARD, BANGALORE"**

1. Karnataka Ayurvedic and Unani Practitioners Board is an autonomous body under the Government of Karnataka which came into existence as per Karnataka Act 9 of 1962, The Karnataka Ayurvedic, Naturopathy, Sidda, Unani, And Yoga Practitioners Registration And Medical Practitioners Miscellaneous Provisions Act 1961.
2. This Board has the power to regulate the qualifications and to provide the registration of practitioners of Ayurvedic, Yoga & Naturopathy, Sidda and Unani System of Medicine.
3. Board is constituted by 9 members elected **amongst the registered practitioners** and 9 members nominated by the government amongst registered practitioners the Director of AYUSH is an ex-officio member.
4. The Board has the power to take actions against fake doctors in the state of Karnataka.
